EVENT: All Events, Training Days and Schools Staged by the Fraser Coast Campdrafting and Sporting Club Inc staged during the year 2010 (Hereinafter referred to as EVENT(S))

In consideration for me being allowed to participate in all competitions, events and activities run by the Fraser Coast & District Campdrafting and Sporting Club Inc, I hereby agree that:

- I understand and acknowledge that Team Penning can be a dangerous activity.
- I understand and acknowledge the rules and the safety requirements of the activities in which I wish to participate
- I understand and acknowledge that serious INJURY, PERMANENT DISABILITY or DEATH may result from competing at Team Penning Events or other riding activities provided on the day I may be participating in.
- I understand and acknowledge that I **ride at my own risk**.
- I hereby release, waive, all of my legal rights of action against the Club from any claim, for loss, damage, injury, death or permanent disability howsoever arising and incidental to myself (or my child) attending at and/or participating in an Event organised by this Club. This waiver includes but is not limited to liability for any negligent or tortuous act or omission, breach of duty, breach of contract or breach of statutory duty on the part of this Club, and I release the Club its' assigns, its Office Bearers, Volunteers, Employees or Agents from all such claims whether caused by the negligence of the releasees or otherwise.
- I understand that it is my choice to wear, or not to wear, an approved safety helmet, and understand and acknowledge that by NOT riding with a safety-helmet that I may suffer serious head injuries or death in the event of an accident.
- I understand and acknowledge not to compete whilst under the influence of alcohol or drugs.
- I understand not to ride in a dangerous manner which may cause injury to others or myself.
- I declare that both my horse, my saddlery and myself are in sound condition.
- I consent to receiving medical treatment, including ambulance transport, if the event organisers deem it necessary.

I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY INDEMNITY AGREEMENT AND FULLY UNDERSTAND ITS' TERMS AND FURTHER UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT INDUCEMENT, ASSURANCE OR GUARANTEE BEING MADE TO ME AND INTEND THAT MY SIGNATURE BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
